## **Critical Need for Scholarships**

Desert Hills Lutheran Foundation is engaged in the critically important work of granting scholarship support for future pastors while they complete their education. Increasing costs of education have sharply escalated for seminarians. Tuition alone averages \$16,130 at ELCA seminaries. Add to this the cost of housing, food, and other living expenses and the cost soars to over \$30,000 per year. After acquiring college debt the cost of further education can appear very restrictive to those with gifts for ministry.

What is the solution? The church, meaning all of us committed to the mission of Jesus Christ, must offer resources to ease the fears of debt for future pastors. Some of us are able to do this individually, however most of us may want to find other ways to offer support. This is why our Foundation is committed to giving our members the opportunity to help through gifts designated for seminary scholarships. Memorial gifts, current gifts, estate gifts, stocks, life insurance are all good ways to offer gifts of support.

The Foundation itself has pledged to continue its support of both our current seminarians until they are ready for ordination.
